Orange County Juvenile Court Administrative Order A-200-1-2022 Re: Confidentiality of CASA's Home Addresses

Pursuant to Education Code Section 48200 et. seq., every child is required to attend school in the school district where his or her parent resides.

Pursuant to Education Code Section 56028 (a) (3), a Court Appointed Special Advocate (CASA) may be appointed as a "Parent" under Welfare and Institutions Code Sections 361 and 726, for purposes of making educational decisions for a child.

CASA's have a right to have their home addresses kept confidential for purposes of their personal safety and well-being.

FOR GOOD CAUSE SHOWING, IT IS HEREBY ORDERED that in every case in which a CASA is appointed to make educational decisions for a child under Education Code Section 56028(a) (3), at the time of the appointment the CASA shall file a confidential declaration (Appendix A) setting forth his or her home address and the name of the school district in which the CASA's home address is located. The CASA's supervisor shall verify the address with the school district and also sign the declaration.

IT IS FURTHER ORDERED that the Court shall review the confidential declaration and make an Order designating the school district where the CASA appointed to make educational decisions lives, and where the child is therefore designated to attend classes pursuant to Education Code Section 48200, et seq.

IT IS FURTHERED ORDERED that the declaration filed by the CASA pursuant to this Administrative Order shall remain confidential pending further order of the Court.
