New 2005-2006 Orange County Grand Jury Selected

Santa Ana - Santa Ana - The 19 members and 9 alternates of the 2005-2006 Orange County Grand Jury were selected today from a drawing held in Dept. C1 of the Central Justice Center, 700 Civic Center Drive West, Santa Ana.

The composition of the 19 members of the new Grand Jury include one Hispanic, one Asian, one African-American and 16 Caucasians; 15 males and 4 females. The average age of those selected is 67 years old, ranging from 45 to 79.

Canvassing efforts for prospective Grand Jury members included the following: More than 3,000 applications were mailed to prospective applicants, and flyers that were distributed to 1,190 companies and 111 minority organizations. Also, current members of the Grand Jury and the Grand Jury Recruitment/Selection Committee spoke to organizations and appeared on Spanish and Vietnamese language television and radio programs to inform the community of the opportunity to serve on the Grand Jury.

Following a six-day training program, the members and three alternates will officially take the oath of office and begin their one-year term on July 1, 2005 at 10:00 a.m in Dept. C1. The names of the 2005-2006 Grand Jury members are attached.
