A. Youth Guidance Center

Commissioners Johnson, Lopez, Perring, Rising, Vachet and Winder visited the Youth Guidance Center (YGC) for an inspection on June 5, 2024. Commissioner Perring reported that there are currently 24 boys and 4 girls at the facility. She also reported additional post education/college classes have been expanded to youth. It was reported that there are fewer class closures at YGC.

Juvenile Hall Car Show

Commissioners McClean, Vachet, and Winder attended the Juvenile Hall Car Show on June 2, 2024. Commissioner Vachet reported the Youth Student Council organized the car show which included 80 cars that were on display. Juveniles had an opportunity to converse with car owners who may have had lived experience with the Juvenile Justice System.

Office of Youth and Community Restoration (OYCR) Webinar: Keeping Youth at the Center

Commissioners Johnson, Vachet, and Winder attended the OYCR Webinar: Keeping Youth at the Center on June 3, 2024. Topics of discussion encompassed utilizing art and music, intentionally engaging youth, and acknowledging the youth's yearning to be recognized and heard.

Child Welfare Council (CWC) Youth Justice Committee Meeting

Commissioner Yost attended the CWC Youth Justice Committee meeting on June 5, 2024. She reported on current California initiatives, highlighting the completion and distribution of the Bill of Rights booklet to all Juvenile Justice facilities across the state. Areas of concern included conditions, staffing, and programming.

Child Welfare System Improvement Partnership (CWSIP)

Commissioner Perring attended the CWSIP meeting on June 6, 2024. She announced a collaborative program between the Social Services Agency and Orangewood Foundation aimed at fostering bonds and strengthening relationships between minors and their family members. The program is scheduled to commence in July.

Otto Fischer Graduation

Commissioners Johnson, Perring, Vachet, and Winder attended the Otto Fischer Graduation on June 7, 2024. Commissioner Johnson commended the successful execution of the graduation ceremony, noting that 16 youth successfully graduated.

Behavioral Health Advisory Board (BHAB) Meeting

Commissioner Garfias attended the BHAB meeting on June 10, 2024. She reported that Dawn Smith from Children and Youth Services Behavioral Health Services was consulted about providing more recent suicide rates among youth because the statistics reported were from 2021. She also highlighted a collaboration between the Orange County Department of Education (OCDE) and Children's Hospital of Orange County (CHOC) aimed to address youth mental health. The WellSpace initiatives are designed to offer students a dedicated environment to cultivate social-emotional learning skills. Currently, there are 40 WellSpace sites with plans for an additional 19 sites to be opened soon.
