COMMENTS BY THE JUVENILE COURT

Stacy Ketell, Deputy Court Operations Manager, reported Judicial reassignments with judges settling into their new case types. She also highlighted a mediation program that will be piloted aiming to address exit orders facilitating family reunifications.

COMMENTS BY THE DISTRICT ATTORNEY

Jeff Kirk, District Attorney, reported the hiring of two new attorneys.

COMMENTS BY PUBLIC DEFENDER (JUVENILE JUSTICE)

Arlene Speiser, Public Defender, reported that they are fully staffed with experienced lawyers.

COMMENTS BY PUBLIC DEFENDER (JUVENILE DEPENDENCY)

Richard Cheung, Public Defender, reported that they are fully staffed with experienced lawyers who are actively mentoring new lawyers. They have partnered with Care Court to achieve the goal of helping youth access mental health services.

COMMENTS BY COUNTY COUNSEL

Dana Stits, Supervising Deputy, reported that they have provided service to over 300 youth in the county's jurisdiction. They are fully staffed, but with upcoming retirements staffing may become a concern.

COMMENTS BY ORANGE COUNTY PROBATION DEPARTMENT

Priscilla Suzuki, Division Director of Juvenile Hall, reported that construction has begun with the foundation as well as the perimeter fence which is expected to be completed by March. She also mentioned that Shawn Barry, the current director of the Youth Guidance Center (YGC) and Youth Leadership Academy (YLA), will be transferring to the Los Angeles County Probation AB109 Office. Kevin Moore will be the acting director at the end of February.

COMMENTS BY SOCIAL SERVICES AGENCY

Kristi Fiskum, Deputy Directory of Children & Family Services, reported that the 5-year improvement plan is pending approval from the Board. She also mentioned that they have expanded their recruitment program to improve placement stability. Maureen Mutch, Project Manager, gave a brief introduction and reported that the Winter Open House was a success, with over 400 attendees. They currently serve 66 youth but are anticipating the number to increase. She also mentioned the following upcoming events which include a snow day at Big Bear on February 18, 2025, and a Black History Month Celebration on February 19, 2025.

COMMENTS BY HCA, CHILDREN & YOUTH BEHAVIORAL HEALTH

Paola Bautista, Service Chief II of HCA, reported that the agency's goal is to have a collaborative court liaison in each court hearing to help identify youth with substance use disorders (SUD).

COMMENTS BY HCA, JUVENILE HEALTH SERVICES

Grace Lizardo, Project Manager of HCA, reported that population numbers have been stable. She also mentioned that the Correctional Health Director, Erin Winger, has announced her retirement.

COMMENTS BY DEPARTMENT OF EDUCATION INSTITUTIONAL SCHOOLS

Analee Kredel, Chief of Special Education Services, shared that the Segerstrom Center of the Arts and the Probation Department have been working together to offer Hip Hop classes to students. She also mentioned that they are close to being fully staffed and are in the process of hiring an assistant principal. Raina Lee, Coordinator, reported that they have provided 6,499 services to students. A cross-training program will be launched in the Spring with the goal of cross training all agencies to enhance their partnerships.

COMMENTS BY ORANGE COUNTY SHERIFF'S DEPARTMENT

Sergeant Jeff Jacques reported that they have trained over 500 administrators on threat assessments. In 2024, Sgt. Jacques reported that they completed 258 threat assessments.

COMMENTS BY JUVENILE DEFENDERS

Martha Franco, Attorney, reported that the office is fully staffed and trained.

COMMENTS BY LAW OFFICE OF HAROLD LAFLAMME (MINORS COUNSEL)

Brian Baron, Attorney, reported that they are currently managing approximately 2,000 cases. The standard that they continue to maintain is to not have more than 150 cases per attorney.

COMMENTS BY CASA

Amy Crowley, Lead Advocate, reported that CASA will be celebrating their 40th year anniversary this year. In 2024, they served over 600 youth. The goal of CASA is to provide service (advocates) to 1,000 youth. She also mentioned that Family Findings is launching a pilot program called Search and Report which will improve the opportunities for locating family members for placement.

COMMENTS BY PROJECT YOUTH OCBF

Commissioner Rodriguez gave updates on behalf of Project Youth. She reported that there will be a program that will service parents in early Summer.

COMMENTS BY WAYMAKERS

Hether Benjamin, Chief of Program Office Youth Development Programs, gave a brief introduction and reported parents concerns when visiting their children at Juvenile Hall.

COMMENTS BY OTHER GUESTS

Commander Monteleone and Sergeant Pereyra were in attendance but neither had additional comments to add to Sergeant Jacques' updates for the Sheriff's department.

Commissioners Vachet, Winder, and Yost attended the CSEC Steering Committee on January 23, 2025. Commissioner Winder reported that referrals have increased, and 135 cases were reported in the calendar year 2024. The victim services department will have additional training

for healthcare providers to help identify human trafficking. He also reported that Orangewood has four clinicians onsite to assist the youth.

Short-Term Residential Therapeutic Program (STRTP) Quarterly Forum

Commissioner Winder attended the STRTP Quarterly Forum on January 28, 2025. He shared that agencies were invited to provide updates with intercounty placement being the main topic of discussion. Additionally, he mentioned that the goal of Mary's Path (STRTP) is to focus on family preservation, education, mental health, and community involvement.

Commercially Sexually Exploited Children (CSEC) 3.0 Know More, Do Better Conference Commissioners Vachet, Winder, and Yost attended the CSEC 3.0 Know More, Do Better conference on January 30, 2025. Commissioner Vachet reported that more than 500 middle school students attended the conference. Presentations, slides, and videos were shown to the students to educate them on CSEC.

Office of Youth and Community Restoration (OYCR) Youth Justice Action

Commissioner Vachet attend the OYCR Youth Justice Action webinar on February 3, 2025. She reported that their goal is to educate the youth in the juvenile system about the various resources available to them.
