Office of Youth and Community Restoration (OYCR)

Commissioners Matson, Vachet, and Winder attended the OYCR webinar on January 14, 2025, which was very informative. Legislation regarding AB107 grants for Project Rebound-Rising Scholars was discussed. Also, being discussed was AB2121 which addressed juveniles graduating with state requirements. AB8187 was a topic that was mentioned in the webinar and addresses women health care products made freely available without the need to ask staff for them.

Foster and Kinship Care Education (FKCE) Advisory Meeting
