### **EVIDENTIARY PROCEEDINGS:**

• **IN PERSON:** See Section 367.75 of the Code of Civil Procedure (Remote technology; in person requirements) and Orange County Local Rule 375 (Remote and In-Person Proceedings for Civil). Evidentiary proceedings (such as trials, judgment debtor examinations, or other hearings where oral testimony will be taken) will be in-person absent a prior court order.

#### **NON-EVIDENTIARY PROCEEDINGS:**

Trial Call: On the first date set for trial, the court will hold a trial call at 8:45 am in Dept.
 W8 via the court's online check-in process available through the court's website
 <a href="https://www.occourts.org/general-information/covid-19-response/civil-covid-19-response/civil-remote-hearings">https://www.occourts.org/general-information/covid-19-response/civil-covid-19-response/civil-remote-hearings</a>. All counsel and self-represented parties appearing for such hearings must check-in online at least 5 minutes before the 8:45 a.m. hearing.

- Counsel/self-represented parties should be prepared to announce whether they
  are ready for trial and whether they would like to proceed with a jury trial (if jury
  fees have been posted pursuant to Code of Civil Procedure section 631) or court
  trial.

The court encourages the parties and attorneys to take advantage of remote appearances for non-evidentiary hearings to reduce travel time, parking costs, and potential hearing delays. However, keep in mind that potential technological or audibility issues could arise when using remote technology, which may require a delay of or halt the proceedings. To help avoid such, please log in and test your equipment in advance of the hearing. Also, if technological or audibility issues arise during the proceeding, please call **(657) 622-5908**.

• **IN-PERSON:** Parties preferring to appear in-person for a non-evidentiary hearing may do so pursuant to Section 367.75 of the Code of Civil Procedure and Orange County Local Rule 375.

#### EX PARTES —

- Comply with all requirements for ex partes, including "an affirmative factual showing in a declaration containing competent testimony based on personal knowledge of irreparable harm, immediate danger, or any other statutory basis for granting relief ex parte." (Cal. Rules of Court, rule 3.1202(c).)
- A reservation must be made with the courtroom (Department W8, 657-622-5908) by noon the court day before the hearing. File the application by 1:30 pm the court day before the hearing.

- Any Opposition should be in writing and e-filed unless you are self-represented.
   (Orange County Local Rule 352.) File the opposition as soon as you can. The court may decide the *ex parte* on the papers. (Code Civ. Proc., § 166(a)(1).)
- Ex parte applications circumvent the usual notice requirements that are designed to ensure fairness. As such, ex partes are highly disfavored and granted only if absolutely necessary.
- Before applying *ex parte* to advance a motion hearing date, file your motion first.

- **SIGNATURES** Stipulations, pleadings, declarations, and other documents <u>must be</u> <u>signed before submission</u> to the court. Failure to comply will result in the document being rejected.

<u>PUBLIC ACCESS</u>: The courtroom remains open for all evidentiary and non-evidentiary proceedings.

No filming, broadcasting, photography, or electronic recording is permitted of the video session pursuant to California Rules of Court, rule 1.150 and Orange County Superior Court Rule 180.
