3. A guardian ad litem cannot represent the minor in pro per except in a Small Claims action and upon the court's consideration.
4. A separate petition and order is required for each case involving said minor. If a new guardian is appointed, a new petition and order is required for the appointment to be effective.
5. The Petition is submitted ex parte and without hearing.

Use this side if minor is under the age of 14 (or if minor is defendant 14 years of age or older and has failed to apply for appointment of guardian ad litem within 10 days after service of the summons). Use reverse side if minor is 14 years of age or older.
